Waiver and Release of Liability

Express assumption of risk: I, the undersigned, am aware that there are significant risks involved in any physical training regimen. These risks include but are not limited to: falls which can result in serious injury or death, injury or death due to negligence on the part of myself, my training partner, or other people around me, injury or death due to improper use or failure of equipment.

Injury may also result simply from the fact of physical training itself. By its very nature, physical training seeks to have me push beyond my limits in order to produce a physical adaptation of my body. This requires feedback from me to my trainer regarding what is happening with my body.

Excessive work can result (in rare cases) in exertional rhabdomyolysis. I should look for signs of excessive soreness, darkened urine, and pain in the kidney areas in the days following a particularly intense workout. While this type of injury is relatively rare, it can occur due to a number of factors, including (but not limited to) genetic predisposition or dehydration, that may be beyond the control of my trainer.

I am aware that any of these above-mentioned risks may result in serious injury or death to myself and or my partner(s). I willingly assume full responsibility for the risks that I am exposing myself to and accept full responsibility for any injury or death that may result from participation in any activity or class while training with CrossFit Gardendale.



Release: For other good and valuable consideration, the receipt whereof in full is hereby acknowledged, I, my heirs, assigns, administrators and representatives, do hereby completely and fully release, remise, acquit, and discharge forever CrossFit Gardendale, and their respective successors and assigns, officers, directors, partners, employees, agents, servants, employees, affiliates, parent organizations, and insurers, from any and all claims, demands, actions, causes of action, rights to action, suits, damages, expenses, compensation and liability of every kind, character and description, either direct or consequential, at law or in equity, which any party hereto may now have or may have had at any time heretofore, or may have at any time hereafter, or arising from, resulting from, or in any manner growing out of or incidental to any and all matters related to my participation and membership in CrossFit Gardendale, including those allegedly attributed to any negligent acts or omissions of said parties.
