Releaser agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of Illinois and that if any portion of the agreement is held invalid, it is agreed that the balance will, notwithstanding, continue in full legal force and effect.

Releaser, being of lawful age, in consideration of being permitted to participate in CrossFit, does for him/herself and for all heirs, executors, administrators, and assigns, hereby release and forever discharge CrossFit Peoria, its members, trainers, owners, employees, or others who may be associated with CrossFit Peoria, their heirs, administrators, and executors of and from any and every claim, demand, action or right of action, of whatsoever kind or nature, either in law or in equity arising from or because of any bodily injury or personal injuries known or unknown, death and/or property damage resulting or to result from any accident which may occur as a result of participation in CrossFit or any activities in connection with CrossFit, whether by negligence or not.

Releaser gives permission for CrossFit Peoria the use of photographs, videos, and/or likeness of me for advertising purposes.

Releaser further states that he/she has carefully read the above release and knows the contents of the release and signs this release as his/her own free act.
