I acknowledge and affirm that I am in good physical condition, including the absence of any skin conditions that may react to the treatments/facilities provided by Evexia, and have consulted with a physician who approves Client’s use of the Spa and its related services, including without limitation, the sauna, spa, cold baths, compression garment’s.
1. I acknowledge that I will be engaging in activities that involve risk of serious injury, including permanent disability and death, in which severe social and economic losses may result not only from my own actions, inactions, or negligence, but from the action, inaction, or negligence of others, the condition of the equipment and/or the facilities (including parking lots), and/or other risks that may not be known to Client at the this time.

2. I further acknowledge that there are potentially dangerous conditions that are present at the Spa, including without limitation, extreme heat, extreme cold, slippery surfaces and floors, including the presence of water, soap, and associated salts and chemicals.

3. I agree that before I use any of the services and/or facilities at Evexia, that I will thoroughly inspect and examine the facilities and/or equipment to determine whether facilities and/or equipment are in safe proper working condition. In the event that I determine that anything related to the facility and/or equipment is unsafe, I will immediately advise and inform a staff member at Evexia the unsafe condition and I will not utilize the facility and/or the equipment until such conditions are corrected and made safe for use by Client.
4. DESPITE BEING AWARE OF THE RISKS INVOLVED FOR THE USE OF THE SPA AND ITS RELATED SERVICES, CLIENT VOLUNTARILY DES AGREES TO USE THE SPA AND ITS RELATED SERVICES. CLIENT ASSUMES ALL FOREGOING RISKS AND ACCEPTS PERSONAL RESPO FOR ANY DAMAGES FOLLOWING SUCH INJURY, PERMANENT DISABILITY, OR DEATH.

As further consideration for the privilege to use the facilities at Evexia, the Client agrees that neither he/she, nor his/her spouse, domestic partner, heirs, assignees, guardians, or legal representatives will make any claim against Evexia or any of its officers, directors, employees, agents, independent contractors, shareholders, insurance companies, attorneys, affiliates, subcontractors, vendors, landlords, lessors, and/or its successors in interest for any injury, property loss, and/or damages resulting from Client’s presence and use of Evexia and its related services.

CLIENT RELEASES, WAIVES, DISCHARGES, AND COVENANTS NOT TO SUE EVEXIA OR ANY OF ITS OFFICERS, DIRECTORS, EM AGENTS, INDEPENDENT CONTRACTORS, SHAREHOLDERS, INSURANCE COMPANIES, ATTORNEYS, AFFILIATES, SUBCONTR. VENDORS, LANDLORDS, LESSORS, AND/OR ITS SUCESSORS IN INTEREST (COLLECTIVELY, “RELEASEES”) FROM DEMANDS, LOS DAMAGES ON ACCOUNT OF INJURY, INCLUDING DEATH OR DAMAGE TO PROPERTY, CAUSED OR ALLEGED TO BE CAUSED IN WHOL PART BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE RELATED TO THE USE OF THE EVEXIA FACILITIES AND ITS RELATED SERVICES.
