- Injury to the musculoskeletal and/or cardio respiratory systems which can result in serious injury or death
- Injury or death due to negligence on the part of myself, my training partner, or other people around me
- Injury or death due to improper use or failure of equipment
- Injury or death due to a medical condition, whether known or unknown by me.

I am aware that any of these above-mentioned risks may result in serious injury or death to myself and or my partner(s).

I willingly assume full responsibility for any and all risks that I am exposing myself to as a result of my participation in Verdant CrossFit programs/classes and accept full responsibility for any injury or death that may result from participation in any activity, class or physical fitness program. I hereby certify that I know of no medical problems that would increase my risk of illness and injury as a result of participation in a fitness program designed by Verdant CrossFit. Verdant CrossFit informed me that there exists the possibility of adverse physical changes during an exercise program, and I fully understand the same. Verdant CrossFit informed me that these changes could include abnormal blood pressure, fainting, disorder of heart rhythm, stroke, and in very rare instances, heart attack or even death, and I fully understand the same. With my full understanding of the above information, I agree to assume any and all risk associated with my participation in Verdant CrossFit fitness programs/classes.

If I am signing on behalf of a minor child, I also give full permission for any person connected with Verdant CrossFit to administer first aid deemed necessary, and in case of serious illness or injury, I give permission to call for medical and or surgical care for the child and to transport the child to a medical facility deemed necessary for the well being of the child.
